Instructions for AFIN Membership Applications

Individual Farmers

Farmers may become a member for the annual fee of \$50 with one vote.

Farming Corporations

A farming corporation may also become a member for the annual fee of \$50.00 with only one vote OR it may include up to 4 designated voters on their application, with payment of the annual fee then being \$50 per voter. The designated voters can be changed at any time by written notice or e-mail notification to AFIN. However, designated voters can only be added with payment of an additional \$50.00/ voter.

Agri-businesses

Agri-businesses involved in any aspect of the forage industry are welcome and encouraged to join. Payment of the annual membership fee of \$250 permits agri-business members to name up to 4 designated voters. The designated voters can be selected or changed at any time by written notice or e-mail notification to AFIN.

Ag Related Non Government Organizations (NGO)

This category is for non-government research and extension organizations, (e.g. Forage associations, Applied Research associations; and other industry stakeholders (e.g. Livestock associations and other entities like Ducks Unlimited) that support the objectives of AFIN. Payment of the annual membership fee of \$250 permits NGO members to name up to 4 designated voters. The designated voters can be selected or changed at any time by written notice or e-mail notification to AFIN.

Ag Related Government Organizations

This category is for educational institutions; government departments, branches, agencies or commissions that support the objectives of AFIN. Payment of the annual membership fee of \$250 permits government organizations to name up to 4 designated voters. The designated voters can be selected or changed at any time by written notice or e-mail notification to AFIN.

Other Individuals

Individuals not part of the agricultural industry may become members for the annual fee of \$50, but only upon specific approval by AFIN.

AFIN reserves the right to refuse memberships in order to maintain the integrity of AFIN.
